





MINUTES of the ORDINARY GENERAL ASSEMBLY of the International Association "Prehistoric Rock Art Trails"

Lascaux-Montignac (Dordogne-France), 29th November 2018

Taking advantage of the kind invitation of the Department Council of La Dordogne Region and its President Mr Geminal Peiro (Vice-chairman of PRAT-CARP Cultural Route), the Cultural Route (CR) of the Council of Europe PRAT-CARP celebrates its GENERAL ASSEMBLY 2018 at MONTIGNAC (Dordogne, France).



There are 15 full-partners represented (44,11 % of the partnership). The new partners 2018 are not included.

There being no quorum in the first call (17:30 hours), the assembly begins in second call, at 18:30 am. In compliance with the statutes of the association:

ARTICLE 18 – The Assembly will be formed validly in the first place with the attendance of half of the members with full voting rights plus one, and in the second place with whatever the number of members with the said right. The second round will be held at least one hour after the first and in the same place.

DEVELOP OF THE ASSEMBLY AND AGREEMENTS:

The Association's manager, Mr. Fernando Isasi, introduces the Ordinary Assembly and he excuses the absence of the President Mr. Pedro Gómez Ruiz, who for family reasons has not been able to travel to Montignac. For this reason, he invites the Vice President, Mr. Germinal Peiro, to assume the presidency of the Assembly.







1. The presidential table is set up under the presidency of Mr. Germinal Peiro (Vice President of the association), who assumes the presidency of the table, assisted by Mrs. Valérie Chamouton. In addition, Mr. Juan Ignacio Canuto, in his capacity as secretary of the association, Mr. Fernando Isasi, as manager, and Mr. Ramón Montes, as technical coordinator.

2. The minutes of the previous Ordinary General Assembly, held in Trigueros (Andalusia, Spain), dated November 17, 2017, is read and approved unanimously.

3. Reports of the Presidency. The President of the Assembly, Mr. Peiro, give the welcome to all the attendees, thanking institutionally - in his capacity as president of the Departmental Council of La Dordogne - the assistance of the representatives of the partners, from the 6 countries represented in the PRAT-CARP CR.

The association's manager thanks, on behalf of everyone present, the facilities given for the organization of the assembly by the Departmental Government of La Dordogne, including the simultaneous translation FR-EN-ESP made available to the representatives.

Mr Germinal Peiro makes a brief speech about the value of cooperation between regions and countries in Europe, in our case, based on the fact of sharing a valuable Rock Art Heritage recognized by both UNESCO (in some cases), and by the COUNCIL OF EUROPE, for the 161 rock sites/destinations open to the public in the PRAT-CARP CR.

The reports of the presidency, reports of activity (technical) and economic of the 2018 exercise are presented by Ramón Montes and Fernando Isasi, respectively. The reports are approved unanimously by those present. Both reports are incorporated as annexes to this document.

The technical report highlights the great activity carried out on the occasion of the EUROPEAN YEAR OF CULTURAL HERITAGE 2018 and the delivery of the first EUROPEAN ROCK ART HERITAGE quality certification to the destination "Archaeological Area of Siega Verde" (Salamanca, Spain). The Archaeological Park of Rock Art of Campo Lameiro (Galicia, Spain) will be the second destination to receive it. All partners are encouraged to begin the certification process of their destinations.

In the economic report section, it's reported the necessity of pay the membership fees as soon as possible, once the corresponding letters of payment have been received, in order to avoid the frequent liquidity problems that are usually caused by delays / unpaid. This has meant that the Cantabrian Network of Rural Development (RCDR) has not been able to receive the 10,000 euros per year that it has destined as payment for its management labour, including the headquarters costs of the PRAT-CARP association, in the last 2 years, having to assign them to pay the payroll of the technical coordinator, who, otherwise, would not have received their salaries in a timely manner.

It is also noted that, some partners accumulate debts of 2 (even more) years, which is unacceptable. The cases of MateraHUB (Italy), Ministry of Culture of the Board of Andalusia and Ministry of Tourism and Culture of the Region of Murcia (Spain), which owe their respective fees of 2016 and 2017, have not yet been satisfied. of 2018. These partners had already been warned, after the last General Assembly of 2017, of being incurred in one of the cases for the loss of their status as an associate, included in article 12 of the statutes:

ARTICLE 12.- LOSS OF THE ASSOCIATE CONDITION: Associate status will be lost by:

Own will communicated in writing to the Board of Directors





- Death in case of individual Associate or dissolution in case of collective Associate
- Failure to comply with statutory obligations.
- Do not pay the periodic fees established for at least two consecutive periods.

Having warned these institutions throughout 2018 of the need to update their quotas with the Cultural Route, two of them have answered (Junta de Andalucía and MateraHUB -The Region of Murcia has not answered-), although none of them has already proceeded to regularize your situation:

It is unanimously approved to begin a process of expulsion of these 3 associates, informing the interested parties that if, within 90 days they have not proceeded to regularize their situation, they will lose their status as RIGHT FULL PARTNERS of the International CARP Association and their Rock destinations will be removed from the Cultural Route of the Council of Europe of Rock Art, informing of this issue to all appropriate institutions, in particular, to the Government Office of the Enlarged Partial Agreement on Cultural Routes of the Council of Europe, to the European Institute of the Cultural Itineraries, the representative of Spain in the Enlarged Partial Agreement (Ministry of Culture) and the respective presidencies of the affected institutions.

4. The plan of activities foreseen for 2019 is presented. The idea is to continue working in two directions:

On the one hand, to give maximum visibility to the CR with the minimum possible economic investment (for which all partners must collaborate by associating the logo and name of the Itinerary to their events). The obligation to use the Council of Europe logo on publications and websites of partners and their destinations is also recalled.

On the other hand, to keep working on the presentation of projects to European Call. Three calls are adapted to the possibilities of our partnership in 2018-2019: EUROPEAN CULTURE (WEAR ABOUT E_CULTURE & THE BIRTH OF ART Projects), Europe with Citizens and HORIZON 2020 (DERA project). It is approved to submit proposals to the 3 programs.

The need to update the CR's website (www.prehistour.eu) is exposed, over 5 years (the current one was built in 2013). The Technical Unit has requested a budget to generate a new WEB (WORDPRESS), which amounts to 2,500 euros. It is approved that, if possible budgetary (that is, if delinquent institutions pay their arrears), execute as soon as possible.

It is proposed to create a Database of temporary exhibitions produced by the partners of the CR that can be made available to the rest of the partners, to encourage the exchange of exhibition resources among all the partners, which is approved unanimously. The Technical Unit will be in charge of collecting the information and distributing it, facilitating the possible loans and / or exchanges.

The technical unit introduce the question that it exists the possibility of developing -free of charge for the PRAT-CARP association-, a tourist guide of Rock Art in Europe (Free tourist guide, "Rock art in Europe"), by the company CITO - CODE https://www.citocode.com/es. It is unanimously approved that this possibility be explored, with all partners available to the technical unit to provide data and graphic material if this possibility is specified.

The representatives of the Centro Camuno di Studi Preistorici of Valcamónica (Italy), Roberta Alberotanza and Tiziana Cittadini, announce that in 2019 the 20th anniversary of the declaration of Valcamonica as a UNESCO World Heritage will be commemorated. For this reason, the CCSP will organize a series of events, among which it is possible to request the PRAT-CARP 2019 FORUM, on October 24 and 25, 2019. The proposal is approved unanimously.

It is approved to advance decisively in the certification processes for obtaining the EUROPEAN ROCK ART HERITAGE label, for which a specific seminar will take place on the second day of the 2018 Itinerary Forum, dated November 30, 2018.

5. Fernando Isasi introduces the proposal of expenses / incomes forecast for 2019, which is approved unanimously. The necessity of pay the fees as soon as possible, once the payment request is received, is recalled.

The proposal includes a general increase in the amount of the fees (the increase would affect all sections except the upper fee of 2,500 euros which it remains stable), in order to square the balance of expenses / income.

The current fees were approved in the 2015 Assembly, and in 2019 offer an income of 35,150 euros. This income does not allow to cover the expenses expected for 2019, with the increase in costs over the last three years. It is necessary this concept raise to 40,000 euros (7.11% more).
