## DEVELOP OF THE ASEMBLY.

1. Opening and Welcome by Mr. Stefano Dominion (Director of the European Institute of Cultural Routes and executive secretary of the Council of Europe's Enlarged Partial Agreement on Cultural Routes), the PRAT Manager (Fernando Isasi) and the Chairperson (Leoncio Carrascal)

Mr. Dominion sent a warm greeting to all the attendees and invited all of them to involve and take part in all the activities and initiatives of the Cultural Routes' Programme. Besides, he congratulated PRAT-CARP Cultural Route for ten years of the Mention of Cultural Route of the Council of Europe and for the current situation of the network (with 44 partners from 8 countries). Finally, Mr. Dominion offered the support of the EICR and the EPA to improve the structure of PRAT-CARP and to help to expansive the network to other regions and countries.

### Words of the Chairperson to the Assembly:

This year 2020 we are celebrating our 10th anniversary as a CULTURAL ROUTE OF THE COUNCIL OF EUROPE, an achievement obtained in June 2010 by the technical team of our association, based on the experience accumulated (and the partnership formed) since 2005 by the Interreg IIIB SUDE Project named "European Network of Early Settlers and Prehistoric Rock Art" (REPPARP).

This year we should have celebrated many events and implemented many important projects that would have led us to a great celebration in the capital of Georgia, where we would have developed our 2020 Annual Forum thanks to the kindness of the National Agency for Cultural Heritage Protection of Georgia.

However, in March everything collapsed in an unexpected way. A virus of Chinese origin was arriving in Europe and in just a few weeks it introduced us to a dystopian reality of a magnitude we could never have suspected when we said goodbye at Capo di Ponte, at the end of our 2019 Forum.

After an initial confusion period, we began to reorganise our forecast of activities for this year and to adapt progressively to the new situation. Although we thought that the pandemic would pass and in the summer we could recover a certain normality, this did not happen. Today, on this date of 18<sup>th</sup> November, we find ourselves in a similar situation to the one we experienced last April, and just the hope of the arrival of several vaccines from January 2021 gives us hope of resuming our lives by next summer 2021 if nothing else goes wrong.

In spite of everything, and even with all the limitations we had, we must congratulate ourselves because we have been able to keep pulse, being able to maintain a basic activity which, adapted to the new conditions, has allowed us to be visible to society and to the European institutions.

This report does not reflect the activity that we foresaw at Capo di Ponte almost 13 months ago, but it does show a strong effort by our network to resist and remain faithful to our common objectives and interests : to defend and promote the Rock Art destinations of Europe as a unique value of our common past and as an element of cultural and economic dynamization of our regions and populations.

Finally, allow me on behalf of the CANTABRIAN NETWORK OF RURAL DEVELOPMENT to thank you for the confidence you have always shown in our organism as Presidency of our Cultural Route. Since December 2007, we have had the privilege of leading this formidable project. But it is time now so that other institutions assume the leadership and give new impetus to the EUROPEAN TRAILS OF ROCK ART. In that mission you will always find us at your side working from the love to our Rock Art heritage and in the mission of improve the quality life of our European societies, especially, the rural ones.

All the full-members of the Association voted unanimously to this list. The 29 votes received were in favour of this list (100%).

Mr. Germinal Peiro, President of the Conseil Départemental de La Dordogne is appointed Chairman. In his first words as new Chairperson, Mr. Peiro recognized the great work of the previous GB and thanked to all the members the compromise and good work developed between 2016 and 2020.

Mr. Peiro said to all the representatives that the new GB will follow working in the same way as the previous one because of the results in the last years are very positive in all the topics and aspects that have been managed. In this sense, the new GB will be a continuation of the previous one in the great topics.

The new secretary received the order to complete the administrative process in the Ministerio del Interior (Ministry of Home Affairs) of Spain de España in order to update the composition of the GB in the National Register of Associations, where the PRAT-CARP Association is recorded officially.

### 6. Next Meetings / Events

The representatives of the National Agency for Cultural Heritage Preservation of Georgia (Ministry of Culture of Georgia), showed their sadness because due to the global pandemic situation had not been possible to celebrate the 2020 PRAT-CARP forum in Tbilisi as it was foreseen. They reiterated the invitation to celebrate this event in Georgia as soon as possible, as it was approved in the previous Assembly of Capo di Ponte in 2019.

Unanimously, all the representative approved that if it would be possible in 2021, the annual forum will take place in Georgia at the end of the year. If the COVID19 situation would not permit to travel to Georgia, the Governing Board would propose another solution, as a simple meeting by ZOOM like the current one.

Attending to the current situation, the PRAT-CARP Manage Unit did not propose a calendar of events for 2021 to be approved. All of the attendees agreed that, if the situation would improve


during the next months, a proposal of activities will be sent to all the partners in order to develop a normal programme during 2021.
